The candidate should also be entrepreneurial, and have a client-minded focus, with commercial awareness, strong interpersonal and communication skills in liaising with international companies and partners, with an extensive know how of the Israeli industry, real estate, logistics, and technological field.

process of engaging investors prone to invest in Italy, encouraging their investment in the country and building confidence and trust, even in aftermarket support. He/She will assist ITA FDI Team in their investors relations. He/She will be also required to perform administrative and back-office tasks, as well as communication tasks and regular reporting process to the ITA FDI Team.

The candidate may be required to travel in Italy and internationally.

# **Primary responsibilities**

FDI support in investors engagement process

- Support ITA FDI Team in the prospect generation through multiple sources, both online and offline, to successfully integrate the funnel and to maximize the outcome in terms of active contacts, calls, meetings, inquiries
- Support in the investor and project management through the gradual full knowledge and understanding of software tools used by ITA FDI Team
- Support in realizing reports, presentations and documents to track and assess daily activities
- Support ITA FDI Team in organizing promotional activities (events, seminars, conferences, training courses, incoming trips of corporate players and investors to Italy and abroad)

Back-office and administrative activities

- Liaise with companies, investors, corporate players and other foreigner and Italian counterparts sharing program news, solicitations, promotional opportunities, asset needs and more
- Aggregate market research, industry resources, news and articles as necessary to share with the ITA FDI Team in scouting the FDI environment
