Question n. 1: Point 4 b of the invitation bid

Answer: As indicated at point 4, letter b), In order to participate, the contractor shall be based in the USA, and it shall be authorized and licensed to do business in the USA.

Answer: The offer should comply with all least furniture required in the technical description.

Answer: Startups Area, 2-person Workstations, Melamine top, light-colored adjustable legs, possibly included Private screen to divide 2 work areas. Table legs are adjustable requests that can be slightly raised to have a comfortable posture to accommodate various heights of people.

Question n. 4 TECHNICAL QUESTIONS - Economic Offer Point 2:

"We can offer a table with a partition without a screen. Is the screen mandatory?" Answer: Startups Area 4-person workstations; melamine top, light-colored adjustable legs, included Private screen to divide the work areas.

As indicated in Annex 2 (Economic Offer), point 2, the tables should include dividers/screens in order to ensure the people working their comfort and a minimum of isolation.

Question n. 5 TECHNICAL QUESTIONS- Economic Offer Point 7: "Can we offer a metal leg as well?"

Answer: there are no specifications for the material in which the chair legs are made. The product must be an embodiment of Italian quality, design, and style, to reflect the image of Made in Italy, in terms of style, design, and quality.

Question n. 6 TECHNICAL QUESTIONS- Economic Offer Point 8: "Cable solution: are there any specific requirements?"

Answer: Sturdy desk, melamine surface. The work surface with cable solution, with light-colored adjustable legs.
