## INSTRUCTIONS FOR BID ITALIAN TRADE AGENCY @ COVERINGS 2020 New Orleans Convention Center New Orleans, Louisiana April 20th - 23rd, 2020

The Proposal for the Italian Trade Agency (ITA) booth at COVERINGS 2020 must arrive in one **sealed envelope** containing the following **3 separate sealed** envelopes within:

1. **Proposal Details (one sealed envelope)** containing the design and the construction description of the exhibit area and specifically: actual color rendering of the entire area scale 1:100, frontal and side views, brochures, photographs of furniture and lighting fixtures and of any other item to be used in the ITA area.

IMPORTANT NOTE: It is required that the type of all materials are detailed and specified in the proposal (ex. wood, fabric, plastics, etc., including description and technical specifications, ex. Wood type, thickness, etc.).

- 2. **One sealed envelope** containing the following documentation:
  - a) Economic and Financial Solvency Proof of financial solvency;
  - b) The turnover for each of the past 3 years (2017-2018-2019) for the leasing of display structures and services realized in the USA;
  - c) Technical Capability Proof of Technical Capability;
  - d) Major projects carried out in the past 3 years (2017-2018-2019), including amounts and name of the customers.
- 3. One sealed envelope containing the following:
  - a) Signed Form (pages 2-3) with itemized pricing (detailed as much as possible)
