#### **Job description**

The Desk, operating through a dedicated Trade Analyst based at the ITA (Italian Trade Agency) Office in Miami, will carry out the following activities:

- Establish and maintain ongoing, trusted relationships with the various institutions promoting the projects.
- Provide targeted assistance to Italian companies regarding business opportunities and partner identification.
- Support the implementation of initiatives aimed at encouraging the participation of Italian companies in projects in the United States.
- Assist in the organization of seminars and information sessions to present available business opportunities.
- Support the organization of trade missions for Italian companies to the United States, with the objective of meeting representatives of the companies and institutions responsible for the projects and, where possible, visiting the relevant project sites, as well as organizing inbound missions to Italy for U.S. professionals interested in meeting potential Italian partners and investors.



- Organize promotional activities, including trade fairs, conferences, business missions, advertising campaigns, seminars, workshops, and networking events.
- Conduct market analyses, research projects, data collection and processing, and prepare reports and presentations.
- Identify potential U.S. business partners (importers, agents, distributors, suppliers, etc.) for Italian companies and maintain and update the relevant database.
- Develop and strengthen relationships with local authorities, business organizations, entrepreneurs, and industry professionals.
- Provide assistance to Italian companies seeking to establish and/or expand commercial relationships with U.S. companies, and vice versa.
- Draft content for media relations and coordinate with the PR agency.
- Regularly update the ITA Miami website with news and relevant information, as well as manage social media communications.
- Manage project implementation, including planning, budget monitoring and control, administrative activities, and financial reporting.

#### **Mandatory Requirements**

- Permanent residency: US Citizen or Green Card holders. **ITA does not sponsor a working Visa**
- Residency in the US
- Bachelor's degree in economics, International Relations, Business Administration, Marketing or Communication
- Master's degree is welcome.
- A minimum of 5 years of proven experience in marketing, organization of events and communication in private sector
- Fluent in English and Italian (spoken and written).
- Proficiency in Microsoft Office (Word, Excel, Power Point).

**Candidates lacking even one of the above-mentioned requirements will not be considered.**

#### **Preferential requirements a plus**

- Experience in working with governments or public institutions internationally and/or in USA
- Excellent organizational, interpersonal and communication skills
- Professional understanding of social media (Instagram, LinkedIn, Twitter, Facebook) and Marketplaces
- Project management and multitasking ability
- 1 or more qualified references from prior employers

**Salary and Compensation**

Monthly compensation **will be \$ 6,250.00, gross of taxes and any other dues, for a total of \$ 31,250.00 and a bonus based on performance and availability of funds.**

Due to the fiscal status of Italian Trade Agency in the US, the candidate shall be solely and fully responsible for taxes and all related fiscal requirements requested by US laws, both at federal level and state level.

**Health insurance coverage will NOT be offered.**

**Selection procedure**

ITA will acknowledge receipt of all applications, but **only candidates who meet the above-listed requirements will be invited to move forward in the selection process.**

The selection process involves the following skill testing, which will be held on August 10<sup>th</sup>, at 10:30 am

Please note that the application process involves skill testing, as follows:

1. **Written test** in English and in Italian, aimed at assessing relevant knowledge, language included (up to 40 points). The candidates must score at least 35 points to be admitted to the Practical test and to the interview.
2. **Interview**, in English and in Italian, focused on relevant knowledge, motivation, and evaluation of organizational and communication skills (up to 60 points).

The candidate will have to demonstrate excellent interpersonal and communication skills, meticulous work ethic and attention to details, proactive result-oriented approach, project management and multitasking, and ability to work in a team.

**Candidates admitted to testing will receive an invitation via email.**

Please note that:

- The selection will take place in person at the ITA Agency's Office (1 SE 3<sup>rd</sup> Avenue Ste. 1640, Miami, FL 33131).
- If, for any reason, should not be possible to take the tests in person, the selection procedure will be carried out online. In this case, all candidates will be notified in advance.

After testing, each candidate will be ranked on a **100 points scale**.

**Only candidates who scored at least 70 (out of 100 points) will become eligible and shortlisted.**

**The list will be published on the ITA website.**

The position will be offered to the eligible candidate with the **highest score** unless he/she intends to withdraw, resign, or ITA finds later that he/she lacks the eligibility requirements: in such a case, the position will be offered to the next ranked eligible applicant, according to a ranking that will remain valid for a 36 months.

### **Important Notice**

**This selection could be suspended and/or cancelled at any moment and for any reason or no reason by ITA at its sole discretion, without creating by obligation and/or expectation or reliance on the part of eligible candidates.**

The recruitment is subject to a no-objection statement from the Italian Embassy in USA. After final selection of candidates, the contract will be awarded and become effective only upon receiving such official statement, that will take 45 days.

Please note that as an entity that forms part of the Italian public sector, ITA must apply the principles of loyalty, fairness and transparency in any transaction it may enter into and in any dealing, with its partners, customers and suppliers ("Code of Conduct"). ## PRIVACY NOTICE FOR JOB APPLICANTS USA

ICE – Agency for the Promotion and the Internationalization of Italian companies (from now on: ITA or Italian Trade Agency) that in this specific case, operates through its branch of ITA Miami Office (1 SE 3rd Avenue Ste. 1640 Miami, FL 33131 - email: [miami@ice.it](mailto:miami@ice.it) ) is the data controller of the personal data that we collect from you as part of the recruitment process. This means that we are responsible for deciding how we hold and use personal information about you.

We are committed to protecting your privacy and complying with the General Data Protection Regulation (GDPR). This privacy notice explains how we collect, use, share and protect our personal data during the recruitment process.

### What personal data do we collect and why?

We collect various types of personal data from you as part of the recruitment process, such as:

- Your name, contact details, date of birth, gender, nationality, immigration status, and any other information that you provide in your resume, cover letter, or application form;
- Your education, qualifications, skills, experience, achievements, and any other information that you provide in your resume, cover letter, or application form;
- Your references, feedback from previous employers, and any other information that you provide or authorize us to obtain from third parties;

- Any information that we collect from biometric identifiers or behavioral biometrics that we may use to verify your identity or for security purposes. This may include fingerprints, voiceprints, facial geometry, keystroke dynamics, or other biometric data.

We collect and use your personal data for the following purposes:

- To assess your suitability for the position that you applied for or any other position that we may consider you for;
- To communicate with you about the recruitment process and your application status;
- To conduct background checks and verification services as permitted by law and as necessary for the position that you applied for or any other position that we may consider you for;
- To comply with our legal obligations, such as verifying your right to work in the United States of America or reporting to tax authorities;

We will only collect and use your personal data if we have a valid legal basis for doing so. The legal bases that we rely on are:

- Our legitimate interests or those of a third party. We will always balance our interests against your rights and interests;
- A contract or pre-contractual measures. This applies if we enter an employment contract with you or take steps to do so at your request;
- A legal obligation. This applies if we are required by law to collect or use your personal data.

#### **How do we protect your personal data?**

We take appropriate technical and organizational measures to protect your personal data from unauthorized access, use, disclosure, alteration, or destruction. These measures include:

- Using passwords, firewalls, antivirus software, and other security tools to protect our systems and networks;
- Limiting access to your personal data to those who need it for the purposes that we have disclosed to you;
- Training our staff in confidentiality policies and procedures;
- Conducting regular technical reviews of our data protection practices and systems.

#### **How long do we keep your personal data?**

We will only keep your personal data for as long as necessary for the purposes that we have disclosed to you. The retention period will depend on various factors, such as:

- The nature and type of personal data;
- The purpose and outcome of the recruitment process;
- Our legal obligations and rights;
- Our legitimate interests.

We will delete or anonymize your personal data when it is no longer needed for the purposes that we have disclosed to you. If we are unable to delete or anonymize your personal data due to technical or legal reasons, we will securely store it and isolate it from any further processing until deletion or anonymization is possible.

### Who do we share your personal data with?

You have the following rights in relation to your personal data:
