MARKET SURVEY NOTICE

ITALIAN TRADE AGENCY IN LJUBLJANA: SELECTION OF AN ECONOMIC OPERATOR FOR EMPLOYEE PAYROLL SERVICES FOR A PERIOD OF 36 MONTHS.

DESCRIPTION OF THE CONTRACTING AUTHORITY:

The Italian Trade Agency (ITA), Trade Promotion Section of the Embassy of Italy in Slovenia, is the Governmental Agency that supports the business development of national companies abroad and promotes the attraction of foreign investment in Italy. With a widespread network of offices around the world, ITA provides information, assistance, consulting, promotion and training to Italian small and medium-sized businesses.

The Italian Trade Agency in Ljubljana intends to select an economic operator based in Slovenia that is interested in participating in this procedure and in possession of the general requirements and professional competence, as per articles 80 and 83 of Italian Legislative Decree 50/2016.

OBJECT OF THE NOTICE:

Based on Italian Trade Agency internal administrative regulations, we are selecting an economic operator for the **employee payrolling services** according to the local tax and duty system, for the Italian Trade Agency in Ljubljana including the related reports to the Slovene Financial Administration "FURS" for the duration of three years (36 months).

The contract will be awarded in direct assignment according with: - Italian Legislative Decrees n. 50/2016 and n. 56/2017 (issued in implementation of Directive 2014/24/ EU on public procurement); - Italian Ministerial Decree of 2 November 2017 n. 192, containing the Regulations governing the procedures for the awarding and management of contracts to be performed abroad (issued by the Ministry of Foreign Affairs and International Cooperation); - Guidelines n. 4, issued by ANAC (Italian Anti-corruption Authority) with Resolution No. 1097, 26/10/2016 and Resolution No. 206, 1/3/2018); - Directive 214/24/EU by the European Parliament and Council, implemented in Slovenia on 1 April 2016 through the Public Procurement Act (ZJN-3).

The offers based on the present notice will be evaluated with **the sole criterion of the lowest price** (as per Art. 95 of the Italian Legislative Decree 50/2016 and subsequent amendments and as per Art. 11 of the Ministerial Decree of 2 November 2017 n. 192) quoted for the payroll services based on Slovene legislation for five Slovenian employees of the Italian Trade Agency in Ljubljana, which are listed hereafter:

- monthly calculation of salaries including meals during work hours, travel to/from work, occasional calculation of sickness leaves reimbursement;
- calculation of Regres (once per year);
- calculation of taxes and dues related to performance bonus (once/twice a year);
- yearly summaries of single employee's salaries;
- all related electronic reporting to "FURS" (obligations of employee as required by the law);
- occasional information related to further rights and obligations.



The Italian Trade Agency in Ljubljana will provide on a monthly basis and in due time the lists of the days worked on-site by each local employee for the above-mentioned calculations.

CHOICE OF ECONOMIC OPERATOR AND AWARD CRITERION:

As previously reported in this notice, the direct assignment will be based on: Directive 2014/24/ EU, Art. 36 paragraph 2 letter a) of Legislative Decree 50/2016 and subsequent amendments; Italian Ministerial Decree of 2 November 2017 n. 192 and Guidelines n. 4 issued by the Italian Anti-corruption Authority-ANAC.

ASSUMED VALUE OF THE FRAMEWORK CONTRACT:

The estimated maximum budget for the above-mentioned services is **1.600,00 Euro** per year, net of VAT. <u>Please note that the signing of the contract remains subject to the approval of the budget by the Director General of The Italian Trade Agency in Rome.</u>

The offer should provide single quotations for each type of the above listed calculation indicating the net amount, VAT (percentage and amount) and gross amount (VAT included) and should also include the cost related to electronic reporting to "FURS". The payments will be carried out by bank transfer for every concluded six-months period.

This notice is aimed at encouraging the participation of the largest number of potentially interested economic operators, therefore the receiving of an offer is not binding for the Ljubljana Office of the Italian Trade Agency, which reserves the right to identify the most suitable subject to entrust with the assignment according to its official regulations.

In case no received offer is considered appropriate or complete, the Italian Trade Agency in Ljubljana reserves the right not to proceed with the assignment of the service object of this notice.

DURATION OF SERVICES:

The duration of the agreement will be of **three years** from August 1st, 2023, with a threemonths test period, once verified the participation requirements. On the expiration date its effects will cease automatically, with no need for any notification between the parties.

The duration of the contract may be extended for the time strictly necessary to complete the procedures to identify a new operator (as per Art. 106, paragraph 11, of the above Italian Legislative Decree 50/2016). In this case the contractor is required to perform the services at the same prices, agreements and conditions of the contract itself.

PARTICIPATION REQUIREMENTS:

The economic operator entrusted with the service will have to commit:

- a) to provide the service in accordance with the Slovene legislation and labour contracts;
- b) to comply with Italian Trade Agency requests respecting the agreed schedule;
- c) to guarantee the use of all the necessary software;
- d) to guarantee, for the execution of the service, its own qualified staff of proven reliability and professional competence.



PAYMENTS AND PENALTIES:

During the three years of validity of the agreement, ITA will provide for the payment of semestral service periods within 30 days from the receipt of the related invoice to be addressed to:

In case the requirements indicated in this notice are not respected within any specific service, ITA reserves the right to apply a penalty, based on the gravity of the event occurred and in any case within 3% of the amount related to the service itself.

The Italian Trade Agency in Ljubljana reserves the right of cancelling the contract with a 30 days' written notice in case the services subject to the contract are not properly carried out.

CLAUSES OF EXCLUSION:

All economic operators who find themselves in the conditions indicated in art. 57 of the European Directive 2014/24/EU - also defined as general requirements as per Art. 80 of Italian Legislative Decree 50/2016 - **are excluded from the present procedure**, and notably:

- a) participation in a criminal organization
- b) corruption

c) fraud

d) money laundering and criminal activities

e) child labour and other forms of human smuggling

f) not compliance with the obligations related to the payment of taxes or social security contributions, established by a judicial or administrative decision, with definitive and binding effect, based on Slovenian and Italian legislation

g) economic operators sanctioned by the Slovenian and/or Italian regulations with the prohibition of signing agreements and stipulating contracts with public administrations.

HOW TO APPLY:

Under penalty of exclusion, the offers - prepared according to the model below and that take into account all the indications contained in this notice - must be sent to the Italian Trade Agency, Office of Ljubljana **via email** at the following address: <u>lubiana@ice.it</u>

This notice will be published on the website of this contracting Agency for a period of **15 days** starting from the day following its publication.



Requests of participation by economic operators interested in this selection procedure must be **signed by the legal representative** of the company, or his delegate.

Applications for participation received after the above deadline will not be considered.

The request for participation does not lead this Administration to any specific obligation regarding the continuation of the negotiation.

CONFIDENTIALITY NOTICE:

The company that will sign the contract has the obligation to keep all the data and information in its possession as confidential, and not to disclose them in any way nor make them object of use for any purpose other than those necessary for its execution//for the execution of the contract.

All confidentiality obligations must be respected even at the end of the contract with the Italian Trade Agency.

The Contractor is also responsible for the observance of the secrecy obligations by his employees and consultants. In case of non-observance of the confidentiality obligations, the Italian Trade Agency has the right to declare the agreement automatically terminated, and the Contractor will be obliged to compensate all the damages that may arise to the Italian Trade Agency itself.

TREATMENT OF PERSONAL DATA:

According to the Italian Legislative Decree n. 196/2003 and the European Regulation n. 679/2016, the collected data will be processed exclusively within the procedure described in this notice.
