NOTICE FOR EXPRESSION OF INTEREST

Notice for companies interested in participating in the selection procedure for the provision of the service "Attraction of Investment from Hong Kong to Italy" of the Foreign Direct Investments Desk (FDI Desk) of the Italian Trade Commission (ITA) in Hong Kong.

The Foreign Direct Investments Desk (FDI Desk) of the Italian Trade Commission in Hong Kong is seeking companies interested in participating in a selection procedure for the provision of the service "Attraction of Investment from Hong Kong to Italy." We are looking to appoint a specialized company for a period of 18 months to attract investments from Hong Kong to Italy in line with the requirements of the FDI Desk.

The appointed company will be responsible for various services, including the development and implementation of annual business plans for promoting inward investment to Italy. They will also act as an interface between the office in Hong Kong and counterparts in Italy, actively promoting Italy as a prime business and FDI destination to investors from Hong Kong and Macau.

The company will need to identify companies in priority sectors and markets, conduct analysis on potential foreign investors in Hong Kong and Macau, and provide timely advice and assistance to potential investors. Additionally, they will promote the Italian portfolio proposed by our Headquarters / Italian counterpart offices and organize meetings, networking events, and investment promotion visits.

Interested companies must be legally registered in the Hong Kong SAR and have experience in the field of investment attraction. They should also possess sound and consolidated experience in the finance and/or investment banking sector, as well as deep knowledge of the industrial and commercial environment in both Italy and Hong Kong. Companies must also meet the requirements set in the Rules and Regulations for Contractors and Suppliers of the Italian Trade Commission – Hong Kong office at the following link:
