This procedure is carried out pursuant to art. 36, paragraph 2, lett. a) of Italian Legislative Decree 50/2016, as emended by art.7, paragraph 2, lett.a) and art. 10, paragraph 1 of Legislative Decree 192/2017, in conjunction with the Guidelines issued by the Italian Authority ANAC, specifically Guideline n.4 - "Procedures for the awarding of public contracts for the amount below the EU threshold relevance, market survey and training and management of lists of economic operators" (Resolution n. 1097/2016).

This notice is published on the website of the Contracting Authority for a period of 15 days starting from the day following the date of publication.
