Pursuant to art. 36, paragraph 2, letter b) of Legislative Decree 50/2016 and subsequent amendments and additions, art. 10 of Ministerial Decree no. 192 of 21 November 2017 in conjunction with Guidelines no. 4, issued by the ANAC in implementation of Legislative Decree 18 April 2016, no. 50, containing "Procedures for the awarding of public contracts for amounts below the thresholds of Community relevance, market surveys and training and management of lists of economic operators" (Resolution No. 1097 of 26 October 2016), and as regards Legislative Decree 19 April 2017, no. 56, it is announced that the ITA Amman intends to initiate a direct procedure for the acquisition of the service in question, proceeding with identification of economic operators — Licensed by Jordanian State, with a minimum of 3 years of experience — interested in participating in the procedure that are in possession of the general requirements and professional competence, as per articles 80 and 83 of Legislative Decree 50/2016.

Content of the requested service:

1. Deep sanitisation of all rooms in office premises on alternate day ; (Rs. per sq.ft per month)

Daily sanitization and cleaning of common areas like toilets, doors, windows in lobby, stairs, doo handles, etc thrice a day . (Rs. per sq.ft per month).

2. Total service area is approximately 120 mq. Quotation shall be inclusive of material costs such as Sodium Hypochlorite, Virex-11, Dettol Disinfectant, Naplon etc

Duration: 6 months

The company must be specialized in this type of intervention. The company must send to our Office a document certifying the sanitization protocol to be carried out, together with all the technical data sheets of the products you will use.

The products used must be certified with respect to use and people. In addition, we would like to agree on a daily sanitization and disinfection plan for the rooms, surfaces, furnishings and equipment in our Office

The quotation does not lead to the Administration having any specific obligation regarding the continuation of the negotiation.
