



















Compreezer[®]: Technology which preserves the ingredients thermosensitive (*fatty ingredients, some vitamins, probiotics*)

Complexation with lipid matrix (solid)

- Improve bioavailability
- Improve solubility in water
- Can grant gastroresistance to a powder
- Can grant special speed release in GI tract to a powder *(ex FITOMINA and FITOSVELIA)*

Active ingredients that are easily degradable or temperature sensitive Active ingredients not compatible with the rest of the formulation




