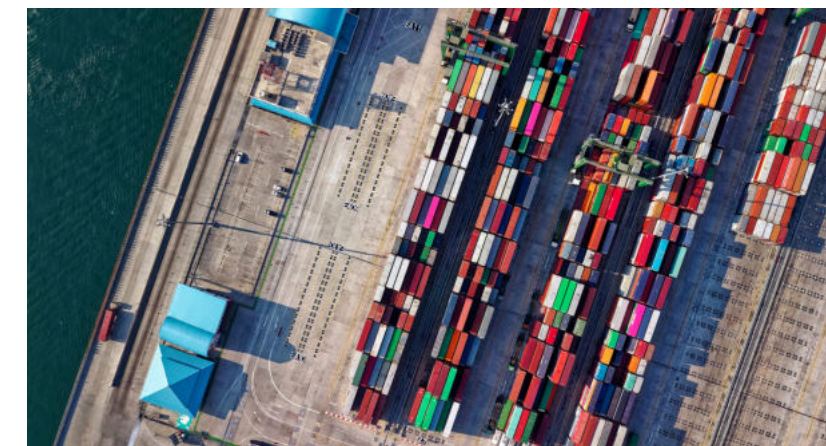
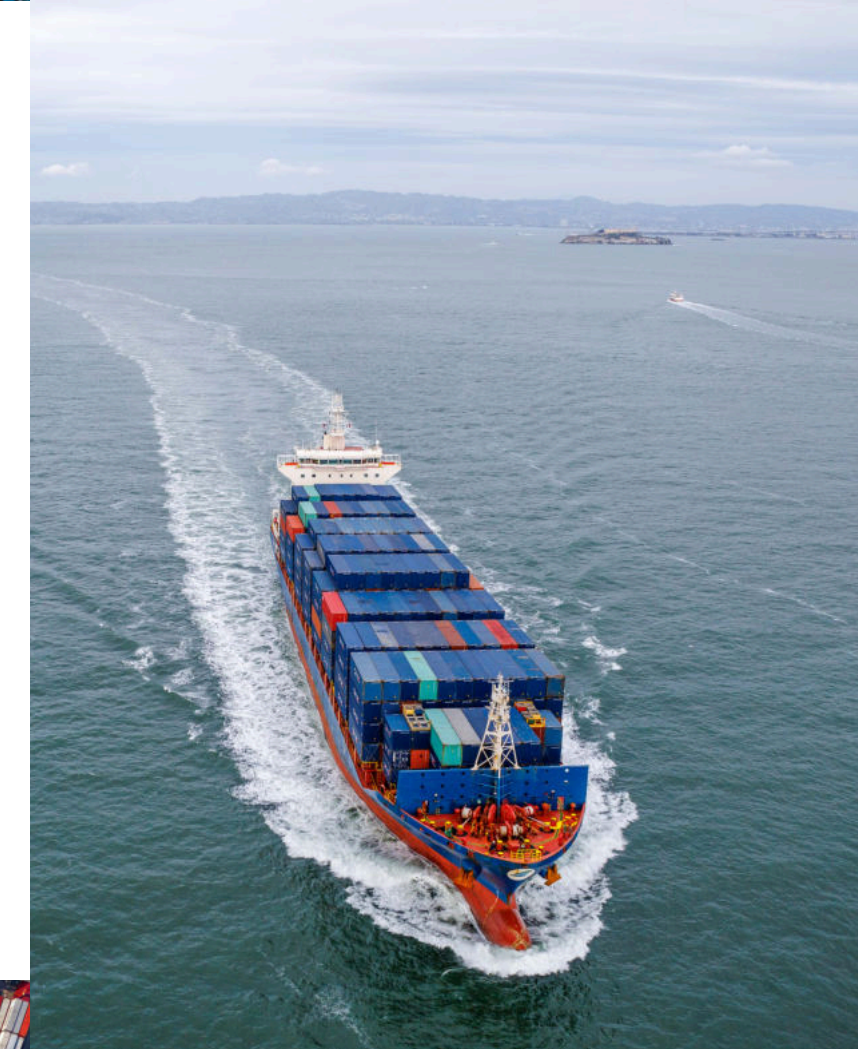

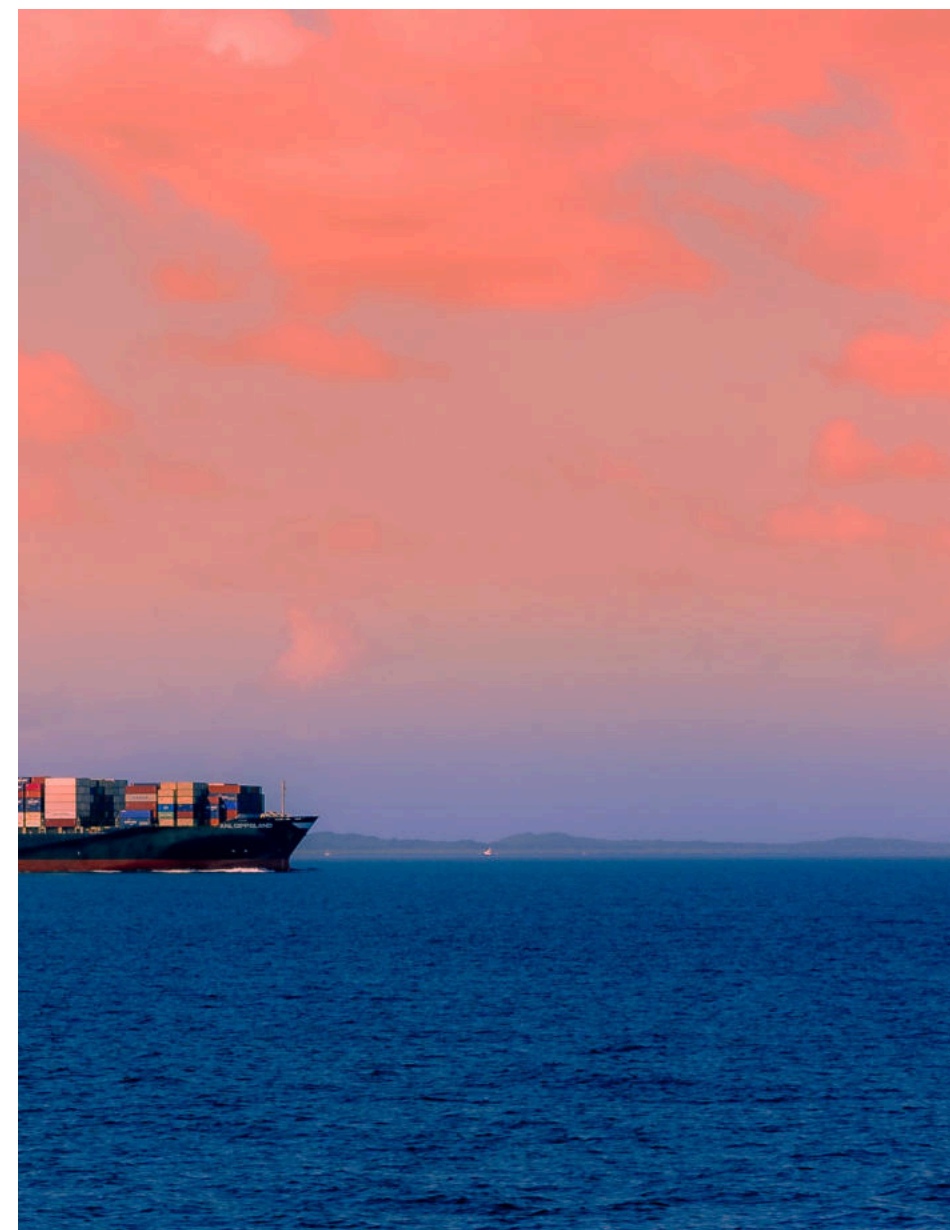
THE DIGITAL PASSPORT FOR YOUR CARGO.

DEFINITION

THE ELECTRONIC CARGO TRACKING NOTE (ECTN) IS A MANDATORY LOADING CERTIFICATE REQUIRED BY MANY AFRICAN COUNTRIES, ESPECIALLY IN WEST & CENTRAL AFRICA, TO REGULATE AND MONITOR SHIPMENTS.

IT CONTAINS:

- SHIPPER & CONSIGNEE DETAILS
- CARGO DESCRIPTION
- VESSEL NAME
- FREIGHT COST & SHIPMENT VALUE

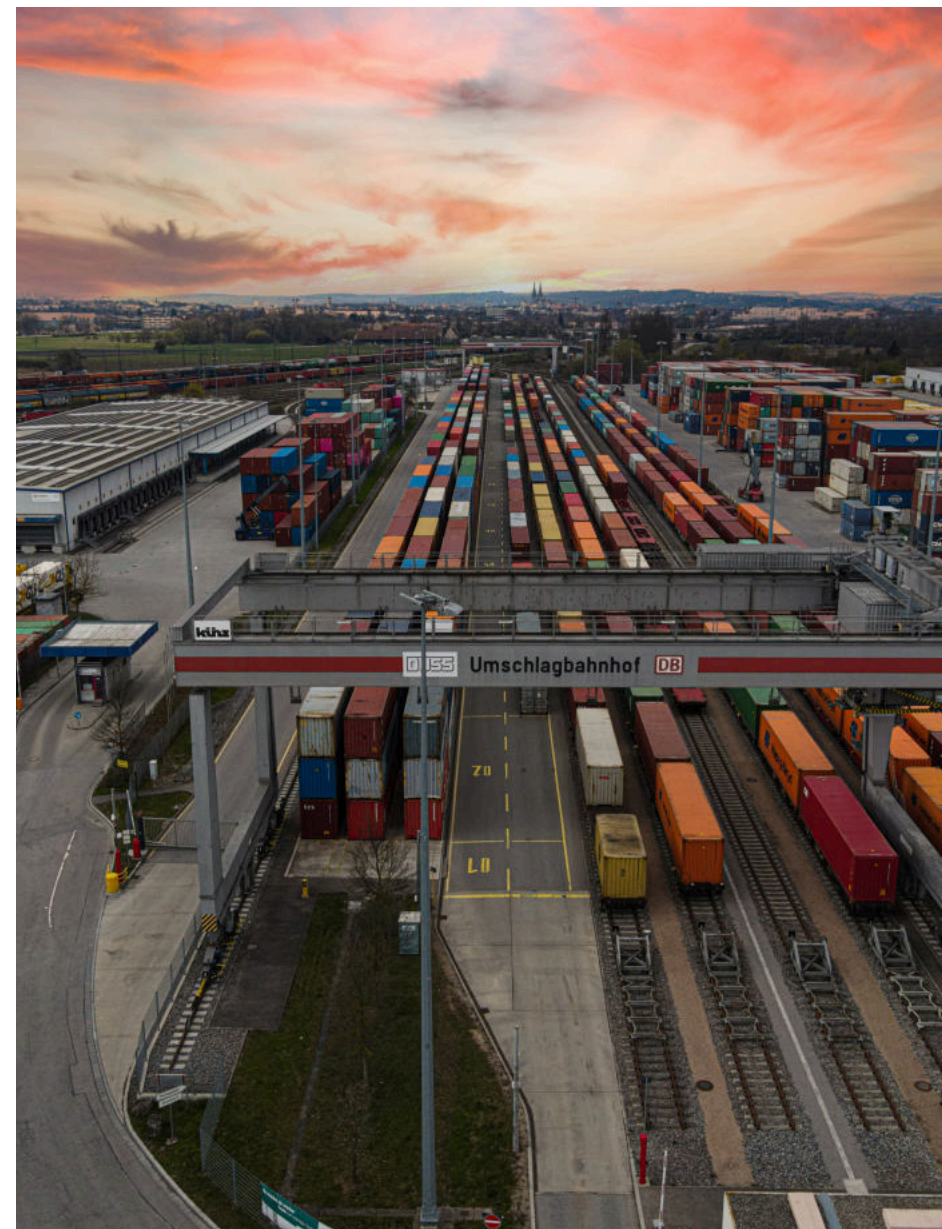

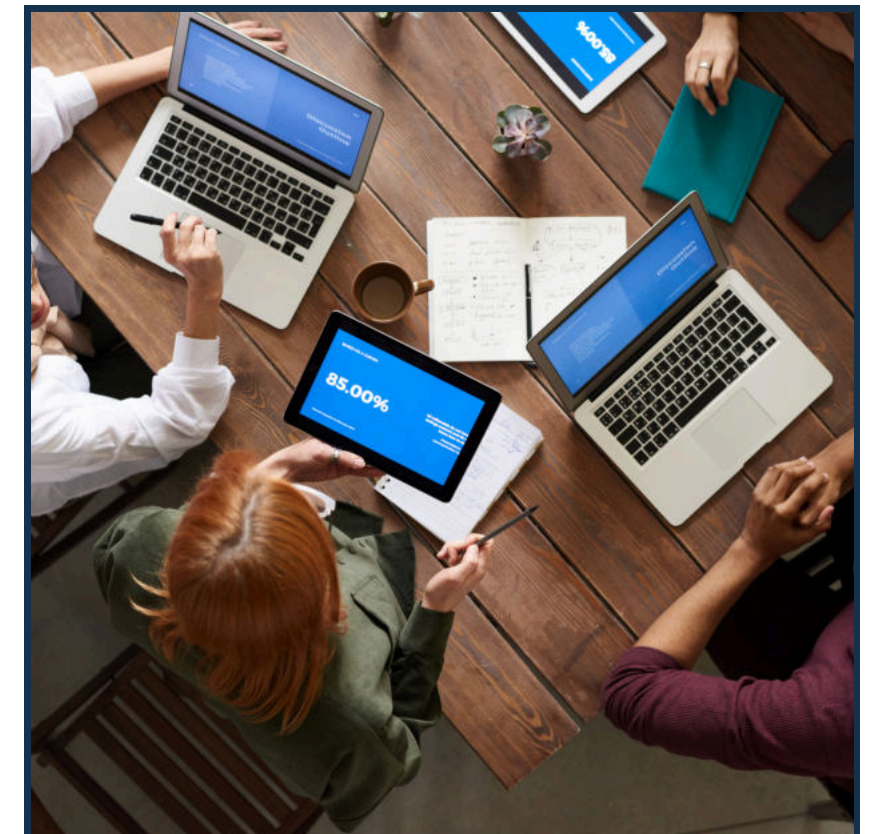
