The Italian Trade Agency ("ITA") is an Italian governmental entity that promotes the internationalization of Italian companies, in line with the strategies of the Italian Ministry of Foreign Affairs and International Cooperation.

ITA also acts as an Investment Promotion Organization - IPO for the attraction of foreign investments to Italy, scouting potential foreign investors and promoting business investment opportunities in Italy.

In addition to its headquarters in Rome, ITA operates worldwide through a large network of Trade Agencies linked to Italian Embassies and Consulates, working closely with local authorities and businesses. Further information can be found at www.ice.it

Job description

ITA is currently seeking a motivated Junior Analyst for a FDI Promotion Project **until 31/12/2024** in order to support the Director of the ITA Office in Vienna.

The ideal candidate should be a research driven, creatively resourceful individual with analytical skills inspired to scour databases, the internet and other sources to identify potential investor for Italian based projects or similar business opportunities.

The candidate should also be entrepreneurial and should have a client-minded focus, with commercial awareness and strong client liaison skills.

During the FDI Promotion Project, the candidate must support the ITA Office in Vienna in order to facilitate the entire process of engaging investors prone to invest in Italy, encouraging and facilitating their investment in the country and building confidence and trust, even in aftermarket support. He/She will assist the Director of the ITA Office in Vienna in his investors relations.

The role will require to perform administrative and back office tasks, as well as communication tasks and regular reporting process to the Italy-based ITA Foreign Attraction Investment Department. Full collaboration is required at working with the Trade Analysts at the ITA Vienna office in all activities aimed at promoting Italy, sharing with them all pertinent contacts and sectorial reports

The candidate may be required to travel in Italy and internationally.

Primary responsibilities

FDI support in investors engagement process

- Support the ITA Office in Vienna in the prospect generation through multiple sources, both online and offline, in order to maximize the outcome in terms of active contacts, calls, meeting, inquiries
- Support in the investor and project management through the gradual full knowledge and understanding of software tools used by the FDI team
- Support in realizing reports, presentations and documents to track and assess daily activities
- Support the ITA Office in organizing promotional activities (events, seminars, conferences, training courses, incoming trips of corporate players and investors to Italy and abroad)



Back-office and administrative activities

- Liaise with companies, investors, corporate players and other foreigner and Italian counterparts sharing program news, solicitations, promotional opportunities, asset needs and more
- Aggregate market research, industry resources, news and articles as necessary to share with the team in scouting the FDI environment

Work location

ITA Office in Vienna Italian Embassy Rennweg 27, 1030 Wien (Austria)

Minimum Requirements

- EU citizenship/permanent VISA (ITA does not sponsor ANY working visa)
- Bachelor's Degree in Economics, Finance or related subjects
- German native level
- Proficiency in English, both oral and written
- Strong computer skills

Candidates lacking even one of the above listed requirements shall not be considered

Preferential Requirements

- Knowledge of the Italian Language
- At least 1 years or more of experience in one of the following: investment promotion, strategic consultancy, business law firms or finance, particularly in investment banking or in sales
- Good organizational skills
- Strong interpersonal and communication skills in writing and speaking (must be comfortable liaising with many international companies and partners)
- Demonstrated leadership abilities and experience working with different cultures, a dynamic, flexible, collaborative, positive attitude and great team spirit
- Ambitious self-starter, ability to take a project and run with it to completion with minimal supervision, excellent project management skills
- Resourceful and proactive, with an ability to identify issues/problems and solve them directly, with high attention to the smallest of details
- Prioritize projects and manage time efficiently, with ability to work in a fast-paced entrepreneurial environment
- Effective strategic consulting skills-ability to develop long-range objectives and provide strategies and actions to achieve them
- Czech/Slovak language

Salary

Gross annual salary: 45.000-55.000 (per year – paid in 14 tranches), determined on the basis of the professional experience and skills of the successful candidate.



Probation period

The selected candidate will be offered a fixed-term contract until 31/12/2024, subject to a probationary period of 1 month from the day of recruitment.

Term

The contract expiration date is 31/12/2024. There will be no tacit renewal and no automatic recruitment after the expire date. If an additional budget for this Project is later approved, an extension of the duration will be considered.

Instructions for candidature submission

Candidates who meet the qualifications and minimum requirements must submit an email to fdi.vienna@ice.it indicating in the object "Junior Analyst – FDI Unit Selection 2023 – ITA Office in Vienna, with the following documents attached:

- Tax Residence in Austria
- Substitutive declaration in attachment, duly filled out and signed
- Pertinent documentation on qualification requirements

The candidates lacking listed qualifications and minimum requirements will not be considered.

The deadline to submit the application is: 10/02/2023

Selection Procedure

Candidates who meet the minimum requirements will be asked to invited for the selection procedure (around 20th February 2023):

- 1. WRITTEN TEST
- 2. COMPUTER TEST
- 3. INTERVIEW

WRITTEN TEST: drafting a summary (translating from German to English or vice versa, without the use of a dictionary) of an article on issues such as international economy.

A maximum of 15 points can be awarded to the written test (passing score: 9 points)

COMPUTER TEST: processing of a text and/or spreadsheet and/or presentation using the Windows office package.

A maximum of 10 points can be awarded to the computer test (passing score: 6 points)

INTERVIEW: in English and Italian (if preferred)

To be admitted to the oral interview on the same topics as the written tests, candidates must obtain not less than the passing score in each test.

A maximum of 30 points can be awarded to the interview including evaluation of preferential requirements (minimum 18 points).

The date of the interview will be provided to suitable candidates.

The ranking remains open for 1 year following the date of publication.



The recruitment is subject to the provision of the Certificate of the Criminal Records, stating the absence of criminal convictions or pending proceedings in Austria and in the selected candidate's country of citizenship.

The recruitment is also subject to a no-objection statement ("nulla-osta di sicurezza") from the Italian Embassy in Vienna. After final selection of candidates, the contract will be awarded and become effective only upon receiving such official statement.

It should be noted that no employment relationship is established between the new recruit from the ITA Agency in Vienna and the Italian Embassy in Vienna, although the new recruit is obliged to comply with the Embassy's Security Regulations, following the instructions given on the matter by the Head of Mission.

Please note that as an entity that forms part of the Italian public sector, ITA must apply the principles of loyalty, fairness and transparency in any transaction it may enter into and in any dealing, with its partners, customers and suppliers ("Code of Conduct"). In addition, it is forbidden to make or accept donations, gifts or other benefits. In case of violations of these obligations the ICE Agency is entitled to automatic termination of the contract. - The interested party may exercise his/her rights at any time, and in particular access his/her personal data, ask for them to be corrected or limited, updated if incomplete or erroneous, and deleted if collected in violation of the law, as well as oppose their processing, without prejudice to the existence of legitimate reasons by the Data Controller.
