Economic and Commercial Profile

Alberta is the 3rd largest economy in Canada by GDP (2022). It is a **major energy jurisdiction** and has the 3rd largest oil reserves, among the highest natural gas reserves in the world.

Although Alberta is a major energy jurisdiction, the Energy sector is now a relatively small part of Alberta's economy. It is a diversified province, and its fastest-growing sectors are not energy – but unconventional energies. They are technology and environment-related. Alberta's many capital-intensive industries, including oil & gas, create strong demand for financial services, trading, mergers, and acquisitions, insurance & fintech.

Fastest growing sectors: green energy, Financial Services, Tourism, Education.

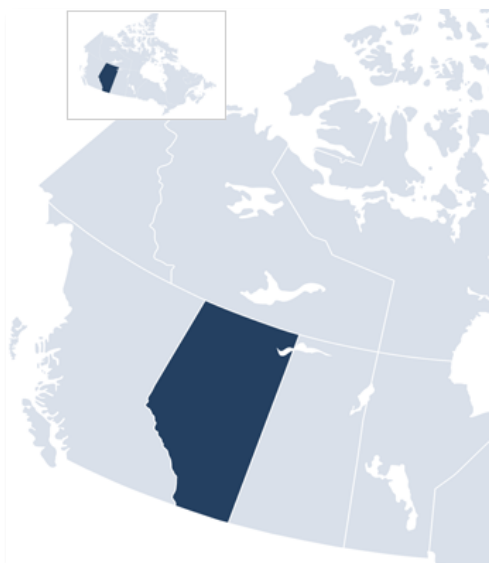

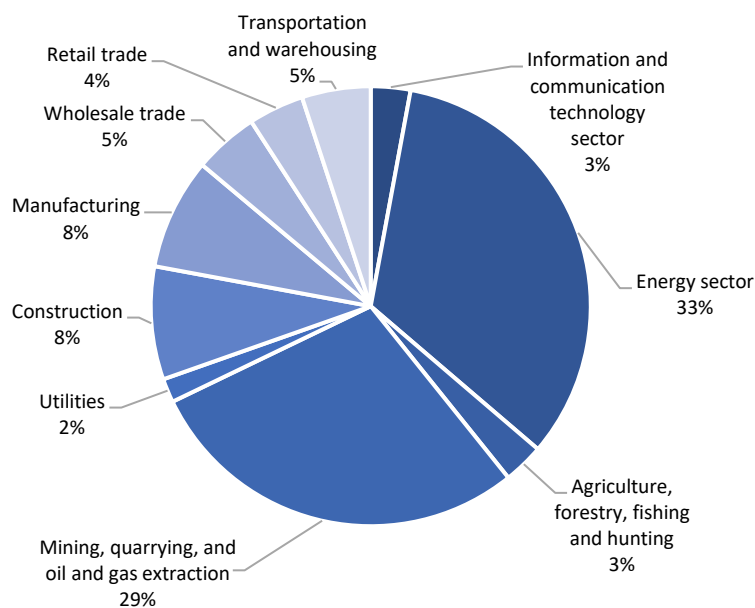

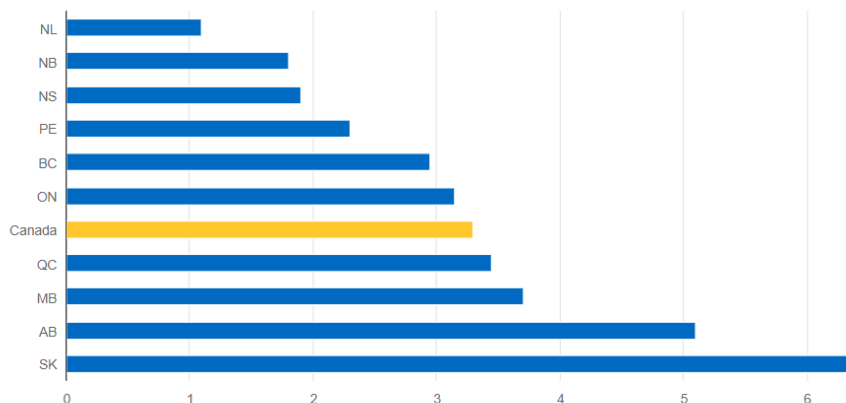

Real GDP Growth 2022 % change

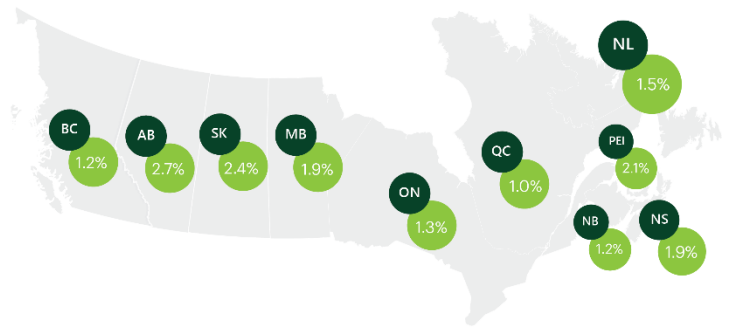

Alberta is one of the most competitive places to invest in North America, with:

- Municipalities can offer up to 15 years of property tax incentives
- Lowest corporate tax rate in Canada 8%
- Low Fuel Taxes
- No payroll taxes, sales taxes, or capital taxes
- Alberta businesses and residents across all income ranges pay the lowest overall taxes compared to other provinces in Canada
- Alberta's tax advantage is \$14.4 Billion in 2020-21 compared to Ontario
- Municipalities can offer up to 15 years of property tax incentives
- Alberta has the **highest provincial GDP per capita** in Canada at \$80,563 (RBC Provincial Forecast)
- Second-highest exports per capita within Canada
- Alberta has more than **700 Major projects** or under construction, representing investments totalling more than \$160 Billion (Alberta Major Projects)

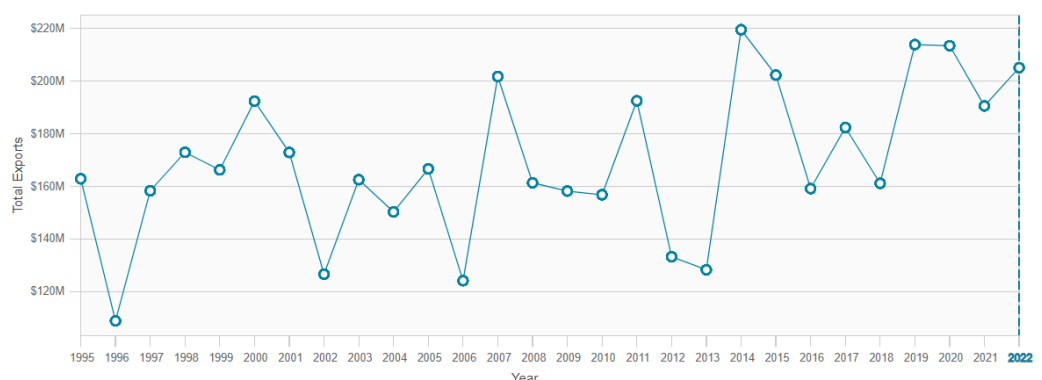

TRADE WITH ITALY

Between 2021 and 2022, Alberta's exports to Italy increased by 7.62% to \$205.1 million.

Over the past five years, exports have changed by 12.44%.

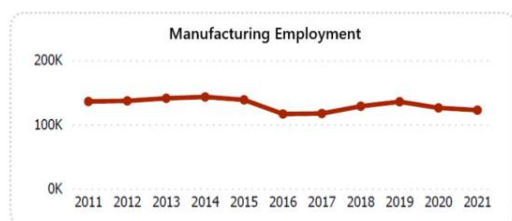

ADVANCED MANUFACTURING

Alberta's major manufacturing sectors include:

- food;
- beverage and tobacco products;
- textile, textile product mills and clothing;
- petroleum and coal products;
- chemical, plastics and rubber;
- computer and electronic products;
- other manufacturing.



MADE IN EDMONTON

Edmonton has an advanced manufacturing ecosystem that is home to nearly 40% of Alberta's manufacturing output, specializing in high value manufacturing of customized products.

Edmonton is home to 40% of Alberta's manufacturing output, and the province is the second largest metal manufacturing hub in Canada. The region is also home to a foreign trade zone, allowing companies to ship materials and unfinished products here where they can be manufactured or assembled and sold to global markets as Canadian products. 35% of manufacturers in Alberta have implemented digital technologies.

NATURAL RESOURCES



The minerals industry (excluding oil and gas) is a vibrant part of Alberta's economy. Non-energy minerals excavated and mined in Alberta include sand and gravel, sandstone and other building stone, iron and magnetite, and gold. Other minerals produced or potentially available in Alberta include:

- **metallic minerals**
- **diamonds**
- **ammonite**
- **other precious stones**
- **industrial minerals**
- **stone**

In 2021, Bill 82, the Mineral Resource Development Act received royal assent which will support a renewed mineral strategy and action plan that will position Alberta as a preferred producer and supplier of metallic and industrial minerals and mineral products.

FINANCIAL SERVICES

Fueled by high levels of investment in the energy sector, Alberta's financial services have seen exceptional growth over the past decade. From 2011-2021, Alberta's growth rate was 38.7% compared to the national growth rate of 35%. Calgary is regarded as one of Canada's four global financial centres, with a cluster of 1,400+ financial services companies that employ over 20,000 people. Calgary is also well-integrated with global markets. Seventy-five percent of the top 20 global investment banks have [branch offices](#) in Alberta. In addition, Alberta will invest over \$1.5 billion in digital transformation for financial services from 2021 to 2024.

AGRI-FOODS

Alberta's agricultural sector is foundational to the province's economy — contributing \$8.1 billion in GDP in 2021 and employing over 58,300 Albertans. The province offers high-quality primary products and is the third largest exporter of agri-food products in Canada.

Alberta produces and exports a significant amount of high-quality primary and processed agriculture products. The province's crop sector is highly diversified including wheat, oats, barley, canola, pulses and more. In 2021, agricultural exports totaled over \$14.1 billion — with \$5.8 billion in primary agricultural products and \$8.3 billion in value-added products. As Canada's leading beef-producing province, Alberta is also a significant exporter of beef and live cattle.

INDUSTRY AND INNOVATION

More than 3,000 technology companies dot Alberta's cities as the province transforms traditional industries and leads emerging innovations.

Alberta's spending on digital transformation (DX) is set to surpass \$20B between 2021-2024, a forecast of 13% year over year growth.

Highlights include:

ARTIFICIAL INTELLIGENCE

Edmonton is one of three hubs at the core of the Government of Canada's Pan-Canadian AI Strategy, designed to leverage and grow the country's expertise in artificial intelligence (AI) and machine learning (ML).

COMPUTER SCIENCE EDUCATION

The University of Alberta's computer science program has experienced an 86% increase in enrolment since 2015.

DIGITAL TRANSFORMATION

Calgary companies will lead the \$20 billion spend on digital transformation in Alberta from 2021 to 2024.

OIL & GAS

As one of the world's largest oil and gas producers, investments into lower carbon fuels and lower carbon energy options can be found here in Alberta. Ninety per cent of major oil producers in Canada – largely in Alberta – have committed to net-zero by 2050 through further emissions intensity reduction, mitigation, and sequestration engineering solutions. Through public-private partnerships with organizations like Emissions Reduction Alberta (ERA), Clean Resource Innovation Network (CRIN) and the Alberta Indigenous Opportunities Corporation (AIOC), industries are disrupting the energy sector and innovating a net-zero future.

PETRO-CHEMICALS



Alberta produces approximately 69 per cent of Canadian natural gas, primarily exporting supply to North America and Eastern Canada by pipeline.

The petrochemicals sector accounts for approximately one-third of Alberta's total manufacturing exports.

Alberta produces 27 per cent of Canada's chemical output.

There is significant potential for investors who are interested in taking advantage of Alberta's vast energy resources and new government development programs to build new petrochemical plants in the province such as the [Alberta Petrochemicals Incentive Program](#), a 10-year grant program launching this fall.

AVIATION, AEROSPACE AND DEFENCE



With the province's strategic location on the CANAMEX Corridor with Canadian Pacific Railways access and three international airports, it's no wonder exports jumped more than 8% between 2017 and 2021.

The Calgary Airport Authority is investing \$2.8 billion over 10 years to meet increasing demand and develop the 330-acre YYC Global Logistics Park while the future of drone technology is taking place at the Foremost UAS Test Range, one of only two Transport Canada-approved locations for unmanned aircraft systems (UAS) testing.

About 16,000 people are directly and indirectly employed in Alberta's **aerospace and defence sector**. Over 500 companies in Alberta's aerospace and defence sector—contributing to Canada's \$24.4 billion GDP in this sector.

TOURISM

The Government of Canada is investing \$17,828,956 in 50 projects to grow Alberta's tourism economy and attract more visitors to the province, bringing economic benefits for businesses and communities.

Investments are being made through the Tourism Relief Fund (TRF), administered by PrairiesCan in the Prairie Provinces. The TRF is a \$500 million program to support the tourism sector in Canada by:

- empowering tourism businesses to create new or enhance existing tourism experiences and products to attract more local and domestic visitors; and
- helping the tourism sector reposition itself to welcome international visitors by providing the best Canadian tourism experiences we have to offer the world.

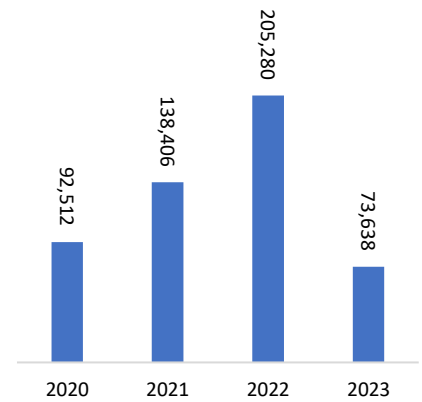

Most Highly Valued Exports by Product Category (%)

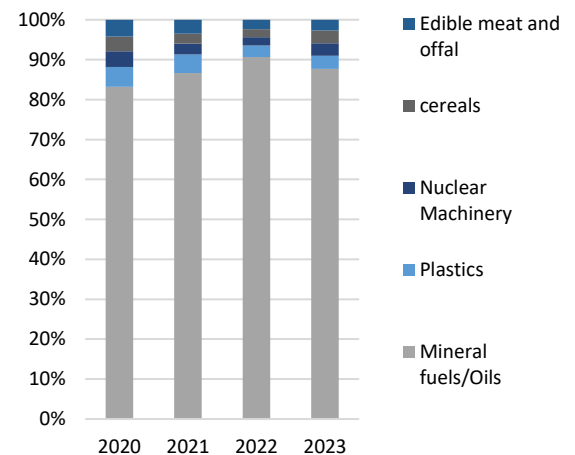

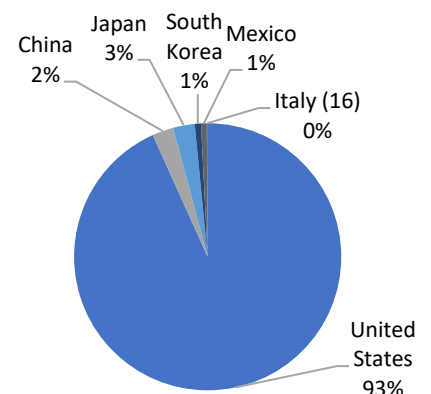

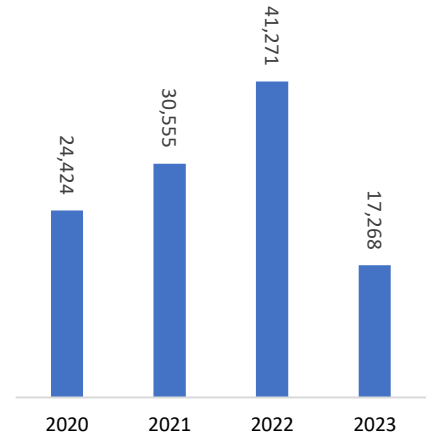

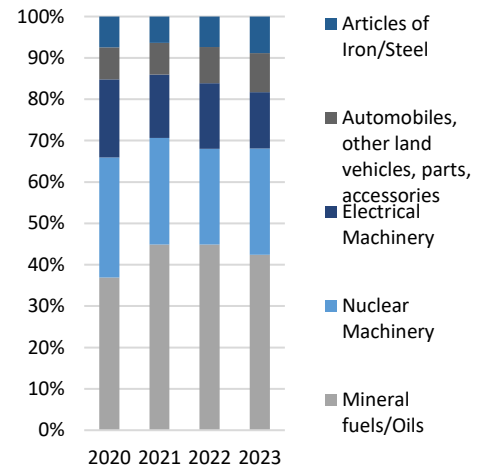
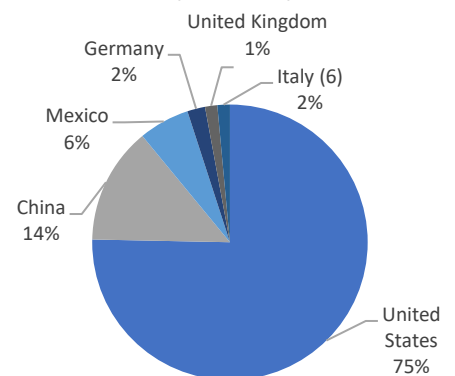

ALBERTA: MAJOR PROJECTS & INVESTMENTS

MAJOR INFRASTRUCTURE PROJECTS – OIL & GAS

Alberta boasts more than 100 years of oil and gas exploration and production history. Its oil and gas related projects are driven by the **Alberta Energy Regulator**, industry, and government needs. Currently one major project in this area focuses on using geoscience to evaluate opportunities and risks from commingled well abandonment.

STRATHCONA REFINERY RENEWABLE DIESEL EXPANSION

Imperial Oil plans to use canola, soy, and/or sunflower oils in combination with hydrogen, produced from natural gas with carbon-sequestration facilities, to make its renewable diesel at its Strathcona Refinery near Edmonton. The project was announced on August 25, 2021.

Slave Lake Bio-Mass/Gas to Liquids Plant

The project, commencing in 2024, will see biomass from the nearby Vanderwell Contractors site be used in a biomass/gas to liquids plant. Upon completion the facility will produce 24,000 liters of biofuel daily.

LIQUEFIED NATURAL GAS (LNG)

Alberta's natural gas has access to Asian and European markets through two to three additional mega LNG projects by 2030.

Shipping from Canada's West Coast to markets in Asia takes half the time than from the U.S. Gulf Coast (10 days versus 20), while proposed projects in Eastern Canada are six to eight shipping days from Europe, which is less than any other North American LNG projects.

CLEAN-TECH INVESTMENTS

Already the Canadian energy capital with 800 oil and gas operations, Alberta is creating pathways for companies to tap into renewable energy, clean tech and petrochemicals. The province was the first in Canada to establish an ESG Secretariat to provide strategic oversight and government coordination for Alberta's clean energy future.

On the institutional side, the **University of Calgary**, the top startup creator among Canadian research institutions, is among the academic partners guiding Alberta's leadership in the energy transition with a business incubator centre and investment in clean energy advancements.

LOW-CARBON ENERGY TRANSITION

Alberta is a leader in energy decarbonization, having made strides in reducing the carbon intensity of its electricity grid as well as its oil and gas sector. This is being achieved through a series of targeted reductions, a transition away from coal, the development of world-scale renewable energy projects, and investment in a growing carbon capture, use and storage (CCUS) industry.

By 2023, power generation in Alberta will be coal free and the electricity grid will produce roughly 20 megatons of GHG emissions a year — less than half the 2015 level.

ABUNDANT, RESILIENT, LOW-COST NATURAL RESOURCES

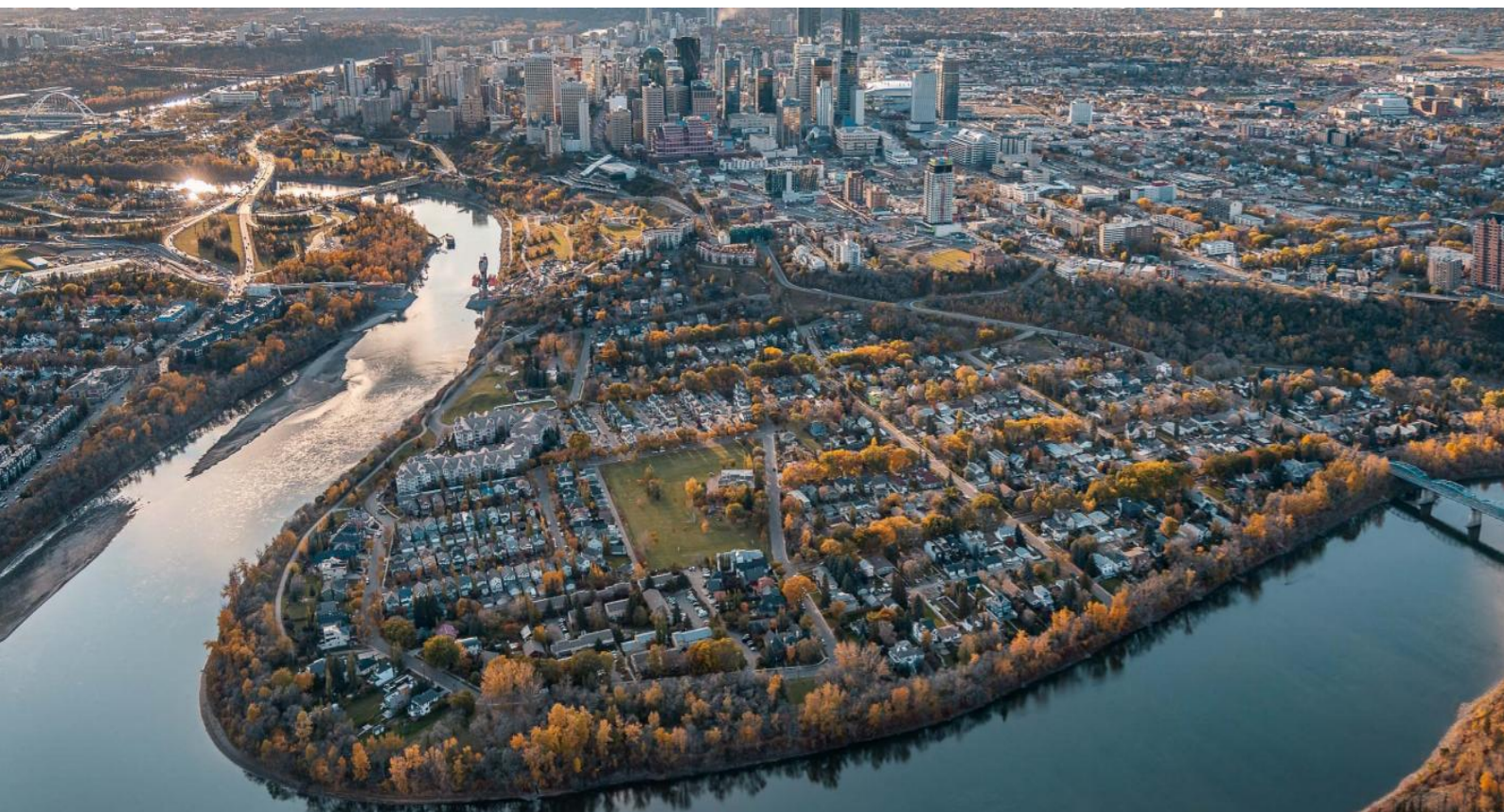
Alberta is home to the third largest oil reserves in the world, 70% of the marketable natural gas in Canada and critical minerals including lithium and magnetite.

Alberta's supply of natural resources is vast and reflects a low-cost basin tested through multiple commodity cycles.
