# TECHNICAL SPECIFICATIONS "ITALY PAVILION"

at

## The BIG 5 Construct Kenya 2024 Nairobi – Sarit Expo Centre

#### **GENERALITY**

ITA - Italian Trade Agency organizes the "Italian Pavilion" the BIG 5 Construct Kenya 2024, Nairobi. For the construction of the Italian Pavilion and the supply of all the furniture and graphic and related services, an example project has been prepared which, together with these technical specifications, provides all the necessary data for the formulation of the offer.

The organization of the project areas could be subject to variations, and therefore the awarded company is required to make all the changes that could occur until the opening of the event on the instructions of the ITA-Agency, without any further burden for the ITA-Agency.

Samples of the materials, photos and/or catalogues and technical specifications, as specified in the letter of invitation, must be submitted during the offer phase, under penalty of exclusion, for each of the supplies identified.

The dates and times of assembly and disassembly of the event in question are indicated in the attached SPECIAL TENDER (Annex C).

It will be the task of the awarded company to draw up the executive drawings of the set- up and submit them to the ITA-Agency for the contract; they will then be presented at its own care and expense to the trade fair body concerned for approval before the start of the assembly work.

The company awarded the contract must carry out maintenance with its own specialized personnel, both during the entire opening period of the event and during the assembly and disassembly phases, thus providing possible assistance to the exhibitors and to ITA-Agency

It will be the responsibility of the awarded company to ensure that the materials, installed systems and stand construction comply with local safety and fire regulations, as well as the exhibition regulations of the host structure and the company organizing the event in question.

It will also be the responsibility of the company awarded the contract, the production, completeness and compliance with the delivery times of certificates and documentation required by the trade fair body.

They will also be paid for by the awarding company:

- static calculations and possible certifications of conformity of the structures;
- certification of conformity of the electrical systems as provided for by the local regulations of the country and/or region hosting the exhibition, as well as the exhibition regulations of the host

structure and the company organizing the event in question;

- transport, assembly, disassembly and disposal of waste and waste materials from the set-up;
- technical assistance and stand assembly with local ITA Staff;
- implementation of the executive project to be presented.

That said, the following points indicate the technical, functional and image characteristics to which the realization will have to respond.

The awarded company shall prepare, on the basis of the specific indications of the "stand construction scheme" attached to the tender documentation, and the requests of the exhibitors, which will be provided by the ITA-Agency, the plan of the ITA-Agency collective with the indication for each exhibition island, the electrical power required and the exact positioning of the switchboards. The company awarded the contract will send the above-mentioned plan to the SARIT EXPO CENTER NAIROBI at its own care and expense and request the supply of electricity, with the relative general electrical panels, distributed in several points within the ITA - Italian Trade Agency collective.

Starting from the general electrical switchboards, the company awarded the contract shall carry out the entire electrical system at its own care and expense (including the supply of any additional elements, couplings, derivations, distributors and accessories of the general electrical switchboards), providing the connections, as well as the supply of secondary electrical switchboards, switches, sockets, cables, junction boxes and anything else necessary for the completion of all work and the perfect functioning of the system.

In this regard, it should be noted that the electrical systems must be carried out in compliance with EEC regulations and/or the regulations in force at the SARIT EXPO CENTER NAIROBI.

Please note that the payment for electricity (connections and consumption), as well as the individual anchorage points of the suspended pylons, will be borne by ITA - Italian Trade Agency.

Reguests to the fair shall be made by the awarded company.

#### DESCRIPTION OF THE INSTALLATION

All furniture and accessories must be of excellent quality and in an excellent state of conservation. Technical data sheets and brochures of the proposed models must be provided.

For the realization of the fittings and furnishings a project has been prepared which, together with these Technical Specifications, provides all the necessary data for the formulation of the offer.

The subdivision and the total square meters are provisional data; therefore the project may be subject to variations, and therefore the awarded company is required to make any changes that may occur until the opening of the event on the instructions of the ITA-Agency, without any further burden.

#### **General Equipment**

#### A - Carpet Flooring Platform (Total Area 216 SQM);

Raised platform flooring and MFC flooring medium brown oak or similar with aluminum edging, covered with protection to be removed at the end of the work.

All the panels are 18mm thick melamine faced chip wood (MFC) with color matching 1mm thick edge banding wherever visible edges are present. (white color)

Hinged honeycomb door flush with the wall, to be mounted on walls partition in MDF cm.  $80 \times 210$ , pure white lacquered finish (RAL9010),
