3. BACKGROUND

ITA is organizing the event "SMAU San Francisco 2024" to be held at Innovit - the Innovation and Culture Hub - on May 21st, 2024, at 710 Sansome St. San Francisco 94111, CA. The event will host a delegation of around 70 among startups, regions and corporate partners, with panels and B2B meetings.

4. SERVICES REQUESTED

Leasing of display structures-furniture and other related services for SMAU San Francisco 2024, as specified in the Annex 1 - Technical Description and in the Annex 3 - Project and including:

- On site supply and set up of high tables, high chairs/stools and office chairs.
- Production, delivery and on site set up of 66 vertical signages.
- Production, delivery and on site installation of 1 acrylic sign.

- Leasing of 20 multiplugs.
- All transportation, costs (inbound and outbound), insurance.
- Dismantling and removal of the displays after the event (including the 66 vertical signages).
- Movement of current office furniture (2-3 office desks and 5-10 office chairs) between floor 1 and floor -1 during setup and dismantling of the event.
- Removal and temporary storage of furniture pieces (see full list in the Annex 3 Project Furniture to be removed).
- All other related labor and material.

5. BUDGET

The total budget will not exceed USD 42,000.00 (forty-two thousand), all included.

Please note that the ITA is a tax-exempt organization.

ITA reserves the right to:

- increase or decrease the contractual amount by a max of 20% as needed without any further obligations towards the awarded Contractor.
- resize the exhibiting space, according to the final confirmation of the total number of participating companies from our Headquarters.

6. MINIMUM REQUIREMENTS FOR PARTICIPATION

In order to participate in this Market Survey, the company shall meet the following requirements referred to in art. 9 of Ministerial Decree 192/2017:

- a) It shall be eligible and possess all the necessary qualifications, in full compliance with local laws
- **b)** It shall be located, authorized and licensed to do business in the United States.
- c) In case your company is chosen to provide the service, it will be required to register in the ITA's Vendor list (see more details at the following link <u>Business Vendor Registration</u>).

The awarding of the contract will be subject to the verification of these general requirements. If the company should fail to meet those requirements for the duration of the contract, ITA

Annex 6 - "Requirements for Direct Negotiation Under the European Union Threshold of Euro 40,000.00" (Documento Unico), duly filled in, dated, signed and notarized along with a photocopy of the signer's valid ID (State issued driver's license or ID or Passport).

Please consider that:

- The quotation must be equal or inferior to the total available budget (\$42,000.00).
- If a discrepancy is found between the proposal indicated in numbers and the one indicated in letters, the lower amount will be taken into consideration.
- The quotation must include <u>transportation inbound and outbound, assembling,</u> <u>disassembling and maintenance</u> of the proposed structure for the duration of the contract.
- Multiple option proposals cannot be taken into consideration.
- For Rules and Regulations, please refer to the Exhibitor Manual of Show Organizers herewith attached.

No offers shall be accepted if:

- Emails are received after the deadline or have been presented in a form other than that indicated above.
- They are conditional or do not clearly accept the conditions required, create misunderstandings as to the contractor's willingness to adhere fully to the said conditions or the indication of the cost;
- They are incomplete, even if emailed within the stated deadline. An offer is deemed to be incomplete if it does not accept all the terms.

8. AWARD CRITERIA AND EVALUATION PROCESS

The contract will be awarded based **on the lowest price**, pursuant to art. 11 of DM 192/2017.

After identifying the best quotation, ITA will award and execute the contract. The award will take place even in the presence of a single quotation, as long as it is deemed valid.

9. NO SUBCONTRACT OF SERVICES

It is expressly forbidden to resort to subcontracts, in consideration of the specific nature of the services, which need a trustworthy interlocutor.

10. CONTRACT DURATION

The contract will run from the date of signing until June 21st, 2024. There will be no tacit renewal of this contract.ITA and the awarded Company shall enter a Contract based on the price offered by the bid awarded company.

<u>IMPORTANT</u>: in case your company is chosen to provide the service, it will be required to register in the ITA's Vendor list (see more details at the following link <u>Business Vendor Registration</u>).



11. TERMS OF PAYMENT

Payments will be made by ITA in USD as follow:

- 20% of the total amount upon signing the contract and presentation of an original invoice;
- 80% balance after the conclusion of the trade exhibition and upon presentation of an
 original invoice, after a successful final inspection of all work and supplies and on receipt of
 confirmation from the exhibition organizers attesting the removal was completed on time
 without causing any damage, and the area was returned to pre-exhibition conditions.

Please note: prior to the payment of the final invoice, a "Certificate of Regular Execution" will be issued by ITA, to certify that the service was fully completed in accordance with the terms agreed. Payment will be made within thirty (30) days upon receipt of the original invoice, addressed to the attention of Director Alessandra Rainaldi - Italian Trade Commission - 12424 Wilshire Blvd, Suite 1400, 90025, Los Angeles, CA.

The ITA makes payments via ACH. The awarding Agency will be required to provide their ACH Routing number and account number so that our payments can be properly credited.

Please note that our office is part of the official Mission of Italy to the United States and is exempt from paying tax on purchases over \$ 325.00.

12. PENALTIES

For each day of delay in delivery or non-compliance with the Technical description and the Additional specifications contained herein, there will be a deduction from the contract's total amount equal to 2% penalty up to ten percent (10%), calculated on the value of the individual service rendered, net of any claim for greater damages, shall be applied.

13. RULES OF CONDUCT OF THE AGENCY AND/OR STAFF OF THE AGENCY

In the execution of the contract, the awarded Company undertakes to fully respect the Code of Conduct adopted by ITA with respect to the provisions of Presidential Decree 62/2013 approved by the Board of Directors by resolution no. 619/23 on 01/27/2023.

14. REFERRAL RULES

For all other terms and conditions not regulated herein, please refer to the provision of Ministerial Decree 192/2017; the civil law governing the conclusion of the contract and the execution phase shall be determined in accordance with the applicable rules of private international law.



15. WHISTLEBLOWING

16. COMPETENT JURISDICTION

In case of a dispute between the Italian Trade Agency and the awarded company, the Court of Law of California, U.S.A., will be competent jurisdiction. In the event of a disagreement between the ITA and awarded company, the prevailing party shall be entitled to recover attorney's fees and costs from the non-prevailing party.
