The Italian Trade Commission (ITC) is seeking applicants for the temporary position of ASSISTANT TRADE ANALYST for its TORONTO OFFICE

Job Title/Level: Assistant Trade Analyst

Type: Temporary/Full time (35 hours/week) starting **January 1, 2021 until June 30, 2021**, renewable for another 6 months upon receipt of a certificate of non-impediment (Nulla Osta) issued by the Italian authorities.

This job offer/posting is for a temporary position created to substitute a staff member currently on a leave of absence. Should said staff member return to work prior to June 30, 2021, this contract will end prematurely with 30 days notice. In the event the absent staff member continues the leave after June 30, 2021, the employment contract may be renewed for another 6 months and prematurely terminating with 30 days notice upon return of said staff member.

Probationary period: 90 days

Term: The position is subject to the Terms and Conditions of Employment for local staff in Canada.

Starting salary: CAD 3,412.50 (monthly gross).

Location: Toronto, Canada

Closing date for applications: November 5, 2020 @ 5 pm.

The role will be to support ITC in enhancing the activity of promoting and assisting Italian companies within the Canadian marketplace through various activities aimed at promoting authentic Made in Italy products in Canada.

The successful candidate will be initially assigned to support a specific sector under the supervision of an experienced Trade Analyst, even though sectors could be changed and reassigned at any time.

Duties & Responsibilities

As part of the temporary contract, the activities and responsibilities for the position, under the direction of ITC, shall be the following:

- Assist with all activities related to the promotion of the sector assigned, including:
- general office and administrative work involved in the organization of promotional activities and events;

• In case of a renewal for another 6 months, a certificate of non-impediment (Nulla Osta) issued by the Italian authorities will be required. Should said staff member return to work prior to December 31, 2021, this contract will end prematurely with 30 days notice,

Application Requirement

To be considered for an interview, applicants must submit the following required materials:

- a signed cover letter explaining the candidate's suitability for the position and how they meet all required qualifications;
- an up-to-date curriculum/resume;
- a copy of the degree and any other relevant certification;
- copies of documentation proving:
 - o citizenships (all must be indicated);
 - o fiscal residency in Canada;
 - o eligibility to work in Canada (a valid open work permit for non-Canadian citizens or proof of Canadian citizenship);
 - o a clean Canadian criminal record check;
 - o in case of Italian citizen, a "casellario giudiziale e dei carichi pendenti";
 - o in case of other citizenship/s, a clean criminal record certificate issued by that country/countries;
- a copy of a valid ID document.

Selection Procedure

ITC will acknowledge receipt of all applications, but only candidates who meet the requirements will be invited to move forward in the selection process.

The selection process will take place in **November (in person or remotely)**, and will include:

- 1. **Written test** in English on a trade related subject (30 min **up to 50 points**). The candidates may score up to 50 points and must score at least 35 points to be admitted to the Practical test and the Interview. (November 10, 2020 at 11:00 a.m.)
- 2. **Practical test:** aimed to ascertain IT skills on Excel, instructions in English (30 min **up to 30 points**); (November 13, 2020 at 11:00 a.m.)



3. **Interview** in English will focus on skills, qualifications, motivation and strength of reasoning (20 min - **maximum score: 20 points**) (November 13, 2020 starting at 11:45 a.m.)

Each candidate will be ranked on a 100 points scale.

The position will be offered to the eligible candidate with the highest score unless the candidate intends to withdraw, resign, or ITC finds later that the candidate lacks the eligibility requirements: in such a case, the position will be offered to the next ranked eligible applicants, according to a list that will remain valid for 6 months.

Reference checks may be sought for candidates that qualify for the selection process.

The Italian Trade Commission does not reimburse any travel costs to and from interviews/exams nor does it reimburse any relocation costs.

This selection could be suspended and/or cancelled at any moment and for any reason or no reason by the ITC at its sole discretion, without creating any obligation and/or expectation or reliance on the part of eligible candidates.
