Dear Economic Operators,

The Embassy of Italy in Tanzania, in collaboration with the Italian Trade Agency (ICE), the Ministry of Foreign Affairs and International Cooperation, and the Tanzania Investment Centre (TIC), warmly welcomes you to the fourth edition of the Italy-Tanzania Business Forum. This event will take place on February 11-12, 2025, at the Julius Nyerere International Convention Centre (JNICC) in Dar es Salaam. We recall that the previous editions were held in Rome (December 2, 2021), Dar es Salaam and Zanzibar (September 28-30, 2022), and Milan (October 19, 2023), all contributing to strengthening the economic and commercial relations between Italy and Tanzania.

This year's Forum holds significant political and technical importance, as it takes place just weeks after Prime Minister Giorgia Meloni announced Tanzania's inclusion in the Mattei Plan. Additionally, in July 2024, Tanzania was included among the priority countries by the Italian Agency for Development Cooperation (AICS).

The United Republic of Tanzania has been a traditionally peaceful and stable country since its inception in 1964. Strategically located at the crossroads of Eastern, Central, and Southern Africa, the country plays a key role in regional trade and cooperation, including within the East African Community (EAC), headquartered in Arusha.

Tanzania is a dynamic and expanding country, increasingly open to foreign investment and international trade. Over the past ten years, the country has experienced steady economic growth, with an average annual GDP growth rate of 5.5%, accompanied by an annual population growth of 3% and improvements in income distribution. This has brought the per capita income to about USD 1,200 per year, placing Tanzania in the lower-middle-income category.

Italian companies have a long history of presence in Tanzania and have proven to be competitive thanks to the quality of their products and services, their ability to adapt to local contexts, and the strength of their partnerships. Numerous Italian best practices testify to the success of this collaboration model in all sectors covered by the Business Forum.

Italy has contributed over time to the socio-economic development of Tanzania, which offers numerous commercial and investment opportunities. This year, we also celebrate the 60th anniversary of the first Economic and Technical Cooperation Agreement between Italy and Tanzania, signed in Dar es Salaam in 1965. Over the years, our actions have also been closely coordinated with the support provided to the country by the European Union in various sectors.

To effectively inform Italian participants about the opportunities offered by Tanzania and to lay the best foundations for concrete operational follow-ups to the Business Forum, the programme also includes numerous testimonies from Italians active in Tanzania for years and field visits (February 13-14), both in Mainland Tanzania and Zanzibar.

Thanks to the collaboration of CONFINDUSTRIA ASSAFRICA & MEDITERRANEO, ANCE (National

Association of Building Contractors), FederUnacoma, and UCIMA (Confindustria Mechanical Engineering), together with our Tanzanian partners, we have developed programme rich of content and activities that will allow you to:

- Participate in plenary sessions with high-profile speakers, including Italian and Tanzanian institutional representatives;
- Delve into specific topics through thematic round tables on Agro-tech and Blue Economy, Green Economy and sustainable infrastructure, and health and pharmaceuticals;
- Establish business relationships through personalized B2B meetings with Tanzanian companies operating in the aforementioned sectors;
- Visit local structures and sites to closely understand and better comprehend investment and partnership opportunities.

We thank you for your participation and wish you the utmost success in your activities. The Embassy of Italy and the ICE Agency are fully available to support your commercial initiatives and investments in Tanzania.

Gentili operatori economici,

l'Ambasciata d'Italia in Tanzania, in collaborazione con l'Agenzia per la promozione all'estero e l'internazionalizzazione delle imprese Italiane (ICE), il Ministero degli Affari Esteri e della Cooperazione Internazionale e il Tanzania Investment Centre (TIC), vi dà un caloroso benvenuto alla quarta edizione dell'Italy-Tanzania Business Forum, che si terrà l'11 e il 12 febbraio 2025 presso il Julius Nyerere International Convention Centre (JNICC) di Dar es Salaam. Ricordiamo inoltre che nel luglio 2024 la Tanzania è stata inserita tra i Paesi prioritari dell'Agenzia Italiana per la Cooperazione allo Sviluppo (AICS).

La Repubblica Unita di Tanzania è un Paese tradizionalmente molto pacifico e stabile, sin dalla sua nascita nel 1964. Strategicamente situato al crocevia tra l'Africa orientale, centrale e meridionale, il Paese svolge un ruolo chiave negli scambi commerciali e nella cooperazione regionale, anche nell'ambito

della Comunità dell'Africa Orientale (EAC), la cui sede è ad Arusha.

La Tanzania è un Paese dinamico e in espansione, sempre più aperto agli investimenti esteri e al commercio internazionale. Negli ultimi dieci anni il Paese ha registrato una crescita economica costante, con un tasso di crescita medio annuo del PIL del 5,5%, accompagnato da un incremento demografico annuo del 3% e da miglioramenti nella distribuzione del reddito. Tutto ciò ha portato il reddito pro capite a circa 1.200 USD all'anno, collocando la Tanzania nella categoria dei Paesi con i redditi medio-bassi.

Le aziende italiane vantano una lunga storia di presenza in Tanzania e hanno dimostrato di essere competitive grazie alla qualità dei loro prodotti e servizi, alla capacità di adattarsi ai contesti locali e alla solidità delle loro partnership. Numerose buone prassi italiane testimoniano il successo di questo modello di collaborazione in tutti i settori oggetto del Business Forum.

L'Italia ha contribuito nel tempo allo sviluppo socioeconomico della Tanzania, che offre numerose opportunità commerciali e di investimento. Quest'anno celebriamo peraltro il 60esimo anniversario del primo Accordo di Cooperazione Economica e Tecnica tra Italia e Tanzania, firmato a Dar es Salaam nel 1965. Nel corso degli anni la nostra azione è stata condotta anche in stretto raccordo con il sostegno fornito al Paese nei diversi settori dall'Unione Europea.

Al fine di informare nella maniera più efficace i partecipanti italiani sulle opportunità offerte dalla Tanzania e di porre le migliori basi per seguiti operativi concreti al Business Forum, i lavori prevedono anche numerose testimonianze di connazionali attivi da anni in Tanzania e visite sul campo (13 - 14
