

**Information on the protection of privacy regarding the processing of personal data**  
REGULATION (EU) 2016/679, art. 13

The processing of personal data is based on the principles of lawfulness, fairness, transparency, to protect the fundamental rights and freedoms of people. For this purpose, the following information is provided:

1. The responsible party for data treatment is ICE – Agency for the Promotion and the Internationalization of the Italian companies (From now on: ICE Agency) that in this specific case, operates through ITA Dubai Office, PO Box 500088 -Dubai Internet City -Arenco Tower- Office 506 & 508 – Dubai UAE, [dubai@ice.it](mailto:dubai@ice.it)
2. ICE Agency appointed a Data Protection Officer who, in the event of questions or complaints, can be contacted at the following address: ICE – Agency for the promotion and the internationalization of the Italian company Via Liszt, 21 – 00144 Roma; e-mail: [privacy@ice.it](mailto:privacy@ice.it).
3. The provision of data is an obligation under Italian Law, and a refusal to provide such data causes the systematic exclusion from the selection procedure or from any assignment.
4. The treatment of data will be carried out manually or electronically by appointed personnel.
5. Data will be communicated to the internal and external control bodies of ICE Agency. By signing this document, the third party gives consent to the communication of such data also to the competent Local Authorities for their verification, and to the publication of the essential elements of the stipulated contract on the client's website, in accordance with the Italian Legislation on Transparency of Public Sector Contracts.
6. Data are kept for a minimum of 5 years from the moment the contractual relationship ends, be it for completion of the execution or for any other termination reason, including termination for default. This deadline is suspended in the event of a judicial proceeding being initiated.
7. The counterpart may request access to personal data and to their rectification. In these circumstances, the party will have to submit a specific request to the address indicated in point 1, copying in such request the person in charge of the data protection of ICE Agency, at the address indicated at point 2.
8. To raise a complaint in relation to violation of any rights, the counterpart may do so with the Data Protection Manager of ICE Agency.
