- Cleaning service from January 2<sup>nd</sup>, 2025 to 31<sup>st</sup> December 2025 (1 YEAR)
   Office:
  - Daily: Dust mop/damp mop floors-vacuum carpeted areas- dust clean furniture and fixtures- dust clean telephones and computers - remove litter from bins deposit in the skip provided by the client;
  - Weekly: Dust clean skirting and sills dust clean cupboards (external); clean internal and partition glass surfaces
- Monthly: Dust clean high ledges dust clean cupboards (external);
   Pantry:
  - Daily: Dust mop/ damp mop floors clean work tops- clean wash basins- clean taps and fixtures;
  - Monthly: Wipe down walls.

Timing of the service: 2 hours daily from 6:00 pm to 8:00 pm from Monday to Friday.
