


CONTEXT OF AGRICULTURE, FORESTRY AND RURAL DEVELOPMENT




- Agriculture contributes with 7.2% in GDP (2018)
- Agricultural export consists of 17% of general value of the export (2019)
- Agriculture has a 22.8% share in total employment (2019)















- The development of the sector of agriculture, forestry and rural development is one of the priorities and it is planned to have a special treatment in the next medium term in order to increase:
- Production,
- Reducing the import of agricultural products;
- Maintaining existing jobs and
- Creating new jobs.
- MAFRD Strategic Plan aims to:
- Supporting investment projects in restructuring the physical potential of the farm;
- Direct support for agricultural production;
- Creating facilities for this sector.





Vision and Mission

- Structured and competitive agriculture with the region, oriented by market demands
- Contribute to the balanced development of the economy, environment, society, cultural welfare and improve the standard of living in rural areas



Objectives



Increasing the competitiveness and efficiency of primary agricultural products, in order to achieve import substitution and exploit export markets;

- Sustainable rural development and improved quality of life (including infrastructure) through the promotion of agriculture and other economic activities which are in harmony with the environment;

- Alignment of Kosovo agriculture with that of the EU
