The Italian Trade Agency, ITA, is a governmental entity with diplomatic status, which promotes the internationalization of the Italian companies, in line with the strategies of the Italian Ministry of Foreign Affairs and International Cooperation.

In addition to its Headquarters in Rome and its Office in Milan, ITA operates worldwide through a large network of Trade Agencies Offices linked to Italian Embassies and Consulates, working closely with local authorities and businesses, providing information, support and advice to Italian and foreign companies.

ITA also acts as IPO – *Investment Promotion Organization* - for the attraction of foreign investments to Italy, scouting potential foreign investors and promoting business investment opportunities in Italy.

Job description

In this context, the Italian Trade Agency Office in Brussels is seeking a motivated Junior Analyst with a University Degree for a **one-year** FDI Promotion Project, in order to support the Foreign Direct Investment activities.

The ideal candidate should be a person with analytical skills, focused on scouring databases, the internet and other sources to identify potential investors for Italian based projects or similar business opportunities.

The candidate, who will work under the coordination of the Director of ITA Office in Brussels, in connection with FDI Division in Rome, will be also required to perform administrative and back office tasks, as well as communication tasks and regular reporting processes.

The candidate, who may be required to travel in Italy and internationally, should be enterprise-oriented and should also have a client-minded attitude, with commercial awareness and strong client-oriented skills.

Duties

During the one-year FDI Promotion Project, the candidate will support ITA FDI team in order to facilitate the entire process of engaging investors interested in investing in Italy from **Belgium, the Netherlands and Luxembourg**, building confidence and trust, even in aftermarket support.

Primary responsibilities

- Support in the leads generation through multiple sources, both online and offline, to maximize the outcome in terms of inquiries, active contacts, calls, meetings.
- Support in realizing reports, presentations and documents to track and assess daily activities.
- Support the ITA Office in Brussels in organizing promotional activities, such as events, seminars, conferences, training courses, incoming trips of corporate players and investors to Italy and abroad.
- Liaise with companies, investors, corporate players, other foreigner, and Italian counterparts, sharing news, solicitations, promotional opportunities, asset needs and more.
- Aggregate market research, industry resources, news and articles as necessary to share with the team of the Office in scouting the FDI environment.

- University Degree in Economics, Finance or related subjects
- Proficiency in English
- Remarkable computer skills
- Tax residence in Belgium

Preferential Requirements

Preference will be given to candidates with the following additional skills and qualifications:

- Good knowledge of Italian, both written and spoken.
- Fluent French and/or Dutch, both written and spoken.
- MBA or PhD in Economics, Finance or related subjects.
- Two years or more of experience in investment promotion, or in strategic consultancy, or in business law firms, or in finance, particularly in investment banking, or in sales activities.
- One or more qualified references from prior employers.
- Good organizational and project management skills.
- Strong interpersonal and communication skills, both written and verbal.
- Working experience with different cultures, proactive attitude and team spirit.
- Ability to take charge of a project and run with it to completion with minimal supervision.
- Ability to identify issues and problems and solve them directly.

- Ability to prioritize projects, manage time efficiently, work in a fast-paced entrepreneurial environment.

Contract term and Salary

The selected candidate will be offered a fixed-term contract for one year.

There will be no tacit renewal and no automatic recruitment after the one-year expiry.

Only in the case an additional budget for this Project would be later approved, an extension of the duration could be taken into consideration.

The gross annual salary is fixed in around 65.000 euro.

Selection procedure

Candidates will be asked to participate in an interview to evaluate the ability to carry out the described activities and to assess the communication skills and the ability to perform the connected tasks.

At the end of the selection procedure, the successful candidate will be asked to provide a certificate, stating the absence of criminal convictions or pending proceedings

Please note that, according to the Italian Law, the recruitment is subject to a no-objection statement ("nulla-osta di sicurezza") from the Italian Ministry of Foreign Affairs and International Cooperation. Therefore, after the final selection of candidates, the contract will be awarded and become effective only upon receiving such an official statement,

Also note that no employment relationship will be established with the Diplomatic and Consular Representations or the Italian Ministry of Foreign Affairs and International Cooperation.

Information on the processing of personal data

- The data will be processed by means of computerised and other tools, and the processing is based on the following legal basis: the performance of obligations strictly related to the recruitment/management of personnel, the provision of data for such activities is essential for the proper management of the contract/employment relationship, or the execution of pre-contractual measures taken at the request of the person concerned (art. 6 point 1 letter "b"); within the limits of the purposes and methods described in this information notice, the following categories of data may be processed as personal identifiers (e.g. name, surname, date of birth, tax code), job position (e.g. role, task), telephone contacts, e-mail addresses, geographical location (e.g. residence, domicile, place of birth), education and culture (e.g. qualifications, professional certifications). - the data are processed by adequately trained staff of the Agency acting as authorized personnel, according to principles of correctness, lawfulness, transparency, relevance and not excessive in relation to the purposes of collection and subsequent processing.

- processing is carried out in such a way as to guarantee adequate security of personal data, through the use of automated tools, including confidentiality and protection, through technical and organisational measures aimed at preventing the loss of data, unlawful or incorrect use and unauthorised access.

The data will not be used for purposes other than and in addition to those described in this notice, without first informing the data subject and, where necessary, obtaining his/her consent.

- The personal data will be kept for a period of time that is congruent with the purposes of processing described above and in compliance with all legal obligations. For the purposes indicated, the data will not be communicated to any recipient.

- The interested party may exercise his/her rights at any time, and in particular access his/her personal data, ask for them to be corrected or limited, updated if incomplete or erroneous, and deleted if collected in violation of the law, as well as oppose their processing, without prejudice to the existence of legitimate reasons by the Data Controller. You also have the right to portability, i.e. to receive in a structured, commonly used and machine-readable format the personal data you have provided.
