### **Final ranking:**

The candidates will be evaluated on a 1-10 scale for each test.

For the additional Italian test the maximum score will be 2/10.

For the additional Arabic test the maximum score will be 1/10.

*Successful candidate will be required to provide original copies of the documents mentioned in the self-declaration.*

### **Salary:**

The basic salary is Euro 31.200,00 for a full-time position.
